

## 2011 FRS Youth Tour

Rural Telephone would like to take this opportunity to inform you of the 2011 Youth Tour sponsored by the Foundation for Rural Service and Rural Telephone Service Co., Inc. This tour invites high school students to Washington D.C. to learn about the telecommunications industry and government processes. The tour also provides students the opportunity to spend four days visiting historic sites in the nation's capital and to meet students from other areas of the country.

Rural Telephone will incur the \$925 registration fee, which covers all Washington, D.C.-based expenses. In addition, Rural Telephone will make travel arrangements and provide a \$150 spending allowance. Applicants for the youth tour must be in high school at an accredited secondary school, have a telephone prefix listed on the attached Exchange Area List, and be age 16 or 17 at the time of the Youth Tour. The Tour will be held June 4-8, 2011.

- Two letters of recommendation from school staff or community members supporting the student's performance and achievements in school and community projects.
- An essay identifying and discussing a significant problem facing their community, including an opinion on what steps should be taken to address the problem and how youth could be involved in this process.

**Eligibility:** Applicants for the Youth Tour must be in high school at an accredited secondary school, have a telephone prefix listed on the attached Exchange Area List, and be age 16 or 17 at the time of the Youth Tour. The tour will be held June 4-8, 2011.

**Cost:** Rural Telephone will incur the \$925 registration fee, which covers all Washington, D.C.-based expenses, including: lodging (four nights at the Doubletree Hotel in Crystal City, VA, two students per room), three meals a day, bus transportation to all activities, admission to ticketed events, special entertainment, airport greeting and transportation, gratuities, a Youth Tour t-shirt, student 'yearbook', student dance with DJ and all supplies and materials. In addition, Rural Telephone will coordinate travel arrangements, incurring the cost for airfare, and providing a \$150 spending allowance.

**Essay:** Each applicant is required to complete a typed, double-spaced essay that will be evaluated on technical accuracy (spelling, grammar, punctuation, etc.) and how clearly the student addresses the following:

- Identify and discuss a significant problem facing your community. In your opinion, what steps should be taken to address this problem? How could youth be involved in this process?

**Applicant Profile:** The Applicant Profile should be typed and attached to the application form. It shall list the applicant's participation in high school and community activities, including years of participation (i.e. Band-2 years; Future Farmers of America-4 years):

- Awards/Honors
- Offices/Leadership Roles
- Clubs/Organizations
- Athletics
- Other School Activities (i.e., band, yearbook, foreign language, speech)
- Community, Church, Civic Involvement/Volunteerism
- Work Experience

**Letter of Nomination and Recommendation:** Students are required to include two letters of recommendation from school staff or community members supporting the student's performance and achievements in school and community projects.

**Application Deadline Date: March 11, 2011, 5:00 p.m.**

Completed applications and supporting documents must be received at the business office in Lenora, Kansas, on or before 5:00 p.m., March 11, 2011.
